Dear Majority Leader Reid, Speaker Boehner, Minority Leader McConnell, and Minority Leader Pelosi:

The Leadership Council of Aging Organizations, a coalition of national organizations that represents nearly 60 million older Americans, strongly supports the Medicare Drug Savings Act (S. 1206/H.R. 2190). This bill would extend Medicaid drug rebates to prescription drugs paid for by Medicare and used by people eligible for both Medicare and Medicaid (dual eligibles), and by people receiving the Medicare Part D Low-Income Subsidy.

The legislation takes a responsible approach to reducing Medicare's costs and improving the solvency of the program. The Congressional Budget Office (CBO) estimates that this proposal would save \$112 billion over the next ten years. These savings are achieved without costs to Medicare beneficiaries unlike many of the other proposals currently under discussion by policymakers.

Precedent for requiring drug rebates for dual eligibles exists in the current Medicaid program. Prior to the implementation of the Medicare prescription drug program through the Medicare Modernization Act of 2003, drug manufacturers were responsible for paying rebates for dual eligibles who received drug coverage under Medicaid. However, once this population began to receive drug coverage through Medicare, the rebates were no longer required. This legislation simply reestablishes and strengthens past policy of rebates for this population who will continue to receive drug coverage through Medicare.

The Medicare Drug Savings Act protects older Americans. As you know, half of people with Medicare have household incomes below \$22,000 per year, and generally the Medicare population already spends on average 15 percent of their income on health care. This is why the Medicare Drug Savings Act is so important; it strengthens the financial outlook of Medicare without doing so on backs of the people the program serves.
