Representative DeGette and Senator Menendez,

The Leadership Council of Aging Organizations (LCAO), a national coalition that represents millions of older Americans, would like to thank you for introducing the "Coordination of Pro Bono Medically Recommended Dental Care Act" (H.R. 4091/S. 1878).

This legislation would offer grant support to national dental programs that provide pro-bono dental care to low-income children and adults. This means that medically-necessary dental services would be provided by volunteer dentists with no cost to patients who have serious medical conditions such as diabetes, cancer, autoimmune disease, kidney disease or those in need of organ transplants. This program would help 5,000 Medicare and/or Medicaid beneficiaries receive much-needed care.

Access to dental services is imperative for the health and quality of life of older Americans who are served by LCAO members. As you know, Medicare does not cover routine dental services and Medicaid only provides very limited coverage in certain states. The lack of coverage for dental services, even when medically necessary, often prevents individuals from getting the care they need and, in many cases, can exacerbate existing chronic conditions.

The inability to access affordable dental coverage is especially difficult for Medicare beneficiaries with limited incomes. Many are unable to pay for the cost of dental care out of pocket and as a result are more likely to go without needed services.

Once again, thank you for supporting Medicare beneficiaries by introducing S. 1878/H.R. 4091, the "Coordination of Pro Bono Medically Recommended Dental Care Act." We hope that Congress will act to provide dental coverage for Medicare beneficiaries in the future, but until then, creating alternative pathways for affordable access to dental services is critical.
