The undersigned members of the Leadership Council of Aging Organizations (LCAO) thank you for your efforts to protect the Low Income Energy Assistance Program (LIHEAP). We greatly appreciated your letter to President Obama on January 18, 2012.

LCAO is a 66-member coalition of diverse national nonprofit organizations dedicated to preserving and strengthening the well-being of older Americans. With a strong commitment to social justice and fiscal responsibility, the coalition serves as a source of information about issues affecting older persons and provides leadership and vision as America meets the challenges and opportunities presented by its aging society.

The LCAO strongly supports the notion that the President's Fiscal Year 2013 budget should contain at least \$4.7 billion for the LIHEAP program. We appreciate your recognition that LIHEAP funding has been a lifeline during the economic downturn and rising energy costs, helping to ensure that people do not have to choose between paying their energy bills and paying for food or medicine. LIHEAP helps many low-income seniors, as well as many families, stay healthy and safe during cold weather months in numerous states across the country (and cool during summer months).

We hope that with your advocacy, President Obama considers the acute need for LIHEAP and the devastating effect cuts to the program would have on seniors and low-income families, and fully restores LIHEAP funding in his FY 2013 budget.
