Dear Representative:

The Leadership Council of Aging Organizations (LCAO) is a coalition of 68 national nonprofit organizations concerned with the wellbeing of America's older population and committed to representing their interests in the policy-making arena.

Signed into law in 1965, the Older Americans Act (OAA) is a primary vehicle for developing, coordinating, and delivering the home and community-based services that help older adults maintain their independence. Since the statute's most recent expiration in 2011, the LCAO has urged Congress to continue the tradition of a bipartisan, timely reauthorization that will strengthen the Act and thus improve the lives of the individuals and caregivers it serves. Today, we remain committed to that goal and ask the 113<sup>th</sup> Congress to ensure its completion.

To that end, we respectfully share the <u>LCAO's consensus recommendations</u> for the reauthorization of the OAA, which can be found on the LCAO website (<a href="http://www.lcao.org/files/2012/12/LCAO-Consensus-Document-on-OAA-Reauthorization-040611.pdf">http://www.lcao.org/files/2012/12/LCAO-Consensus-Document-on-OAA-Reauthorization-040611.pdf</a>) Originally adopted in 2011, the LCAO's recommendations address the economic and demographic challenges facing the OAA and the Aging Network. With our nation's population of older adults projected to grow exponentially in the coming years, so too will grow the corresponding demand on OAA programs. This major influx of older adults will enter an already stressed system, as OAA funding has not kept pace with inflation or population growth for decades and is insufficient to keep up with increased need. Additionally, local, state, and federal resources will continue to be strained into the foreseeable future, due to the economic downturn's lingering effects and the Budget Control Act's current and future reductions.

In this environment of fiscal uncertainty and restraint, the LCAO seeks to preserve and strengthen the OAA without making major changes to the Act's core services or infrastructure. Accordingly, in our recommendations, we look to improve the OAA through greater program coordination, enhanced service delivery, the availability of adequate resources, and heightened administrative flexibility.

The LCAO has played a significant leadership role in past reauthorizations, and we stand ready to work with you to build upon the successes of the OAA in the current reauthorization process and beyond.
