Dear Senators Warner and Isakson:

The Leadership Council of Aging Organizations (LCAO) is a coalition of 72 national nonprofit organizations concerned with the well-being of America's older population and committed to representing their interests in the policy-making arena.

We are writing in strong support of S. 1549, the "Care Planning Act of 2015" and your steadfast efforts to ensure that older adults living with advanced illness or nearing the end-of-life receive person- and family-centered care that is well coordinated and honors their dignity, values, and health care choices at each stage of their illness. Older adults must have access to the full range of high-quality medical care and treatment, including curative care, palliative care, and hospice care, and we believe that your legislation will help move us toward this goal.

Last year, LCAO adopted Advanced Care, Hospice, and End-of-Life Principles (attached), which are well-reflected in the key provisions of the "Care Planning Act." Of paramount importance to our members is care that reflects the goals, values, and preferences of the person. By creating a benefit under Medicare for planning services, beneficiaries will have the greatly needed option of working with a multidisciplinary team to consider the range of treatment options and define the care plan they want to address their physical, medical, and psychosocial needs. Research clearly shows that persons with advanced illness and their families benefit from a series of informed discussions over time about their goals and care options, and your bill will provide the opportunity for these valuable discussions to take place. Further, we support the bill's provisions that direct hospitals, home health agencies, hospices, and skilled nursing facilities to ensure patient preferences are documented and shared with other providers.

We also support the legislation's coordinated services demonstration project, its direction to the Secretary of Health and Human Services to address the gaps in quality measurement in the advanced illness field, and the inclusion of advanced care planning information in the Medicare & You handbook.

LCAO looks forward to working with you as the "Care Planning Act of 2015" moves through the legislative process and would like to discuss various aspects of the bill with your staff in the near future.
