Dear Majority Leader McConnell and Minority Leader Schumer,

On behalf of the Leadership Council of Aging Organization (LCAO), we are writing to express our concern over Section 207 of the Lower Health Care Costs Act of 2019, which passed out of the Senate HELP Committee. Section 207 removes the long-standing requirement that medicines marketed in the United States adhere to quality standards established by the US Pharmacopeia.

The Leadership Council of Aging Organizations (LCAO) is a coalition of national nonprofit organizations concerned with the well-being of America's older population and committed to representing their interests in the policy-making arena. LCAO serves as a source of information about issues affecting older adults and provides leadership and vision as America works to meet the challenges and opportunities presented by our aging society. Our organizations have expertise in health care, economic security, nutrition and food security, housing and other issues facing older adults and people with disabilities. We are committed to advancing public health and promoting access to affordable medicines to keep older adults healthy and improve their well-being and the well-being of their families.

The existing public transparent standards are a compendium of drug information that is produced annually by the United States Pharmacopeia, an independent, not-for-profit and nongovernmental entity. The current standards it develops help ensure consistency in the quality of medicines as mandated by U.S. laws. They reassure doctors, pharmacists and patients that medicines contain the ingredients promised on the label at the promised dosage and purity, and serves as a set of standards internationally for more than 100 other nations. Law enforcement agencies also use these public standards to stop counterfeit or substandard drugs from entering our country and harming patients.

The repeal of the U.S. Pharmacopeia requirement would not increase the number of lower-cost biosimilars available to American patients. It could, instead, deter biosimilars from coming to market as manufacturers of follow-on products use the current system of standards to develop their own products in order to meet the same level of safety and effectiveness. Congress has rejected similar language previously, in 2016.

We urge you to not include this harmful provision in final Senate drug legislation. The lack of public standards could potentially jeopardize the quality of biologic medicines and harm patients, especially older Americans.
