Dear Chairwoman Murray, Ranking Member Blunt, Chairwoman DeLauro, and Ranking Member Cole:

The Leadership Council of Aging Organizations (LCAO) is a coalition of 66 national nonprofit organizations concerned with the well-being of America's older population and committed to representing their interests in policy-making arenas. LCAO thanks you for your efforts to support older Americans as they age at home and in the community.

We ask that you strengthen programs serving older Americans as you finalize the fiscal year 2023 appropriations. Many of the federal programs under the jurisdiction of your Appropriations Subcommittees help older adults age with dignity, health, and independence in their homes and communities and provide vital support to their family caregivers.

Increased investment is of paramount importance to address existing supports and services shortfalls, increase availability to address the growing older adult population, and improve and expand access to services for atrisk older adults and their caregivers. This is particularly essential as our nation continues to address the effects of the COVID-19 pandemic.

At this time, we urge Congress to fund programs and services for older adults at levels that reflect the true and growing need in communities across the country and that, in turn, will help to build a stronger and more equitable American economy. With 10,000 people turning 65 each day, all federally funded programs are serving more older adults every day, whether by assisting Social Security beneficiaries and their caregivers, staffing Adult Protective Services and the Long-Term Care Ombudsman Program, or addressing the needs for in-home help, meals, social engagement, transportation, and other assistance to be able to age well at home through the Older Americans Act programs.

Long-term continuing resolutions (CR) fail to address these needs and impede recovery when our country needs it the most. Relying on long-term CRs results in flat funding that does not account for growth in programs or demographics of an increasing older adult population. Multiple CRs impede strategic and cost-effective planning affecting critical service availability. We have the solutions, and we know how to best serve older adults in our communities - we just need the funding to support these best practices.

We encourage you to pass final Fiscal Year (FY) 2023 appropriations that include the adequate funding levels prioritizing and promoting the dignity, health, and independence of older adults while supporting their family caregivers. We ask you to consider LCAO's funding requests below, and refer to the justifications in our May 2022 correspondence.
